Our fee for the services of funeral director and staff includes, but is not limited to, staff response to the initial request for service; arrangement conference with family or responsible party; arrangement of funeral; preparation and filing of necessary local authorizations and permits; recording vital statistics; staff assistance prior to, during, and following the funeral, including cemetery, crematory, and others. Also included in this charge are overhead expenses relative to our facility such as insurance, maintenance, and utility expenses; clerical and administrative costs; and equipment and inventory expenses. This fee for our basic service and overhead will be added to the total cost of the funeral arrangements you select, and is included in our charges for cremation, immediate burials, forwarding and receiving remains, and our funeral packages.

B. Embalming \$600

Embalming is intended to temporarily preserve the remains and enhance the appearance of the deceased. Except in certain cases, embalming is not required by law. Embalming may be necessary if you select certain funeral arrangements such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement which does not require it, such as direct cremation or immediate burial.

Cremation Policy

Additional weight fee of \$150 will be accessed for cremations 300 pounds or more. Our crematory will not accept metal caskets for cremation. The remains must be removed from the casket and placed in a Durable Cremation Container. The casket will be disposed of if left at our facility. The splitting of cremains to additional urns or keepsake jewelry will be charged a fee of \$25 each plus \$12 for each additional burial permit. All containers for cremations must be constructed of composite material and/or heavy cardboard. All remains received for cremation must be encased in a durable, combustible container.
